Above mentioned 02 (Two) firms have participated in the Financial Bid. It has been observed by member (representative of Finance Department) after opening of Financial proposals, the amount quoted by 1st lowest Bidder M/s. Shahzad Associates is higher than the PC-I provision. However chair appraised the forum that the same is within the permissible limit of 15% of the cost of the Scheme. Hence the chair and Committee members unanimously agree and recommended for further process.
