Sub: Training of Trainers of Faculty Members for De escalation of violence

Dear Prof. Devrajani,

Healthcare in Danger is a joint project of APPNA Institute of Public Health and International Committee of Red Cross which aims to support health systems by preventing and controlling violence against health care by promoting safer access through increased acceptance and security to healthcare workers. The project started with a mixed methods study in Karachi in 2015 which lead to formation of interventions to prevent and control Violence in Healthcare. In subsequent years, AIPH has developed and implemented different interventions including training for Healthcare Providers on De-escalation of Violence against them.

The iCRC together with a team of public health experts and administrators of health care facilities developed a training manual to enable the health care workers to manage violence within health care settings by enhancing their communication skills, verbal and non-verbal techniques to de-escalate aggression and their ability to manage stress. The aim of the trainings would be to encourage and enable the institutes to train the healthcare work force to have a better interaction with the patients. After training they will be able to recognize and de-escalate the violence against them.

We would like to offer this training of de-escalation to faculty members of your institute, after training identified people would be able to deliver trainings periodically at your hospital as a Master Trainers. Kindly identify the faculty members from your institute who can take over this responsibility. It will be two days training for Master Trainers comprising of 5 modules with interactive sessions from 9 am till 1 pm (tentative timings).
