Purpose: To promote a healthy and safe environment by prohibiting smoking and tobacco use in Liaquat University of Medical and Health Sciences, Jamshoro.

Scope:

This policy applies to all:

- Students
- Faculty
- Employees
- Visitors

Policy Statement:

Liaquat University of Medical and Health Sciences, Jamshoro is committed to maintaining a smoke-free environment. Smoking and tobacco use are prohibited on all premises, including:

- Buildings
- Grounds
- Parking areas
- Company vehicles
- Outdoor areas

Prohibited Products:

- Cigarettes
- Cigars
- Pipes

- Electronic cigarettes (e-cigarettes)
- Vaping devices
- Chewing tobacco
- Snuff
- All other tobacco products

Responsibilities:

- Employees: Comply with policy, report violations.
- Management: Enforce policy, provide support.
- Security: Monitor premises, address violations and report to the authority.

Consequences of Non-Compliance:

- Verbal warning (first offense)
- Written warning (second offense)
- Disciplinary action (third offense)
- Termination (repeated offenses)

Support for Quitting:

- Smoking cessation programs
- Counseling services
- Nicotine replacement therapy (NRT)
- Prescription medications

Signage:

- Clear signage indicating smoke-free premises
- Posted at entrances, exits, and throughout premises

Effective Date:

Review and Revision: This policy will be reviewed and revised as necessary.

Benefits:

- Improved health and well-being
- Reduced risk of smoking-related illnesses
- Increased productivity
- Cleaner environment
- Compliance with regulations

LUMHS has established a complaint process for policy violations.

- Communicate policy to contractors, vendors and visitors.
- Post policy on company website and intranet.
- Review and update policy annually.
